In response to your correspondence dated February 3, 2020, the Canada Border Services Agency (CBSA) - International Events and Convention Services Program (IECSP) officially recognizes the following event:

2020 Jukasa Motor Speedway Events

June 6 & 20, 2020

July 11, 2020

August 8, 13 & 22, 2020

September 4, 5 & 26, 2020

Jukasa Motor Speedway

Hagersville, Ontario

The information provided to the CBSA states there will be approximately **4000** attendees per event to which **15%** are foreign to Canada and that the event is open to the general public with no sales.

As outlined in your correspondence, this event is expecting approximately **100 to 200 entrants, drivers and crew from the United States** who will be importing racing vehicles, trailers and conveyances, repair parts and equipment such as tires, wheels and spare parts, tools and portable shop equipment, mobile accommodations, kitchens and related equipment and support personnel, safety vehicles such as first response vehicles and mobile medical unit and related equipment, a maximum of three full fuel taker trucks and television production trucks and related equipment for use at the event.

It has been determined that this event qualifies under the provisions outlined in tariff classification number **9993.00.00.00**. The following list of goods qualify for temporary importation under this tariff item and may enter Canada free of duty and taxes, provided the items will be exported upon the completion of the event:

1. Racing vehicles
2. Trailers and conveyances for moving racing vehicles
3. Repair parts and repair equipment such as tires, wheels and spare parts
4. Tools and portable shop equipment required to maintain a racing vehicle
5. Mobile accommodations, mobile kitchens, and related equipment when imported to support the racing team and support personnel and used to promote race related activities.
6. Safety vehicles such as first response vehicles and mobile medical unit and related equipment for use solely at the racing event.

7. A maximum of three full fuel tanker trucks for each racing event. The fuel will be for use only in racing vehicles and not support vehicles. Following the race, any remaining fuel in the tanker trucks will be exported.
8. Television production trucks and related equipment to produce segments covering your racing events.

Fuel in excess of the normal tank capacity of the racing vehicles, oil, grease, and other consumables are subject to payment of duties and taxes at time of importation into Canada. Listings of goods being imported should be prepared indicating description, quantity and values.

Goods imported for sale are not eligible under tariff classification number 9993.00.00.00. These goods must be accounted for at time of release on a Form B3, Canada Customs Coding Form. Commercial release processing is fully explained in Customs Memorandum D17-1-5.

Goods imported as "giveaways" must be accounted for at time of release on a Form B3, Canada Customs Coding Form, with all applicable duties and/or taxes collected at the time of importation.

The CBSA requires a security deposit on goods temporarily imported to Canada. Normally, these goods are documented on a *Temporary Admission Permit (E29B)*. Under certain circumstances, the CBSA may waive the requirement for goods being temporarily imported to be documented on the E29B as well as the posting of a security deposit. Provided at the time of importation, the conditions of temporary importation previously described are met, the IECSP recommends that both the requirement for the above listed goods to be documented on a Form E29B and the posting of a security deposit be waived.

The CBSA requires everyone seeking admission into Canada to properly declare themselves to the CBSA by providing accurate identification. The CBSA will accept a valid passport as proof of citizenship.

Persons who have been convicted of any criminal offences may be inadmissible to Canada. For more information please visit: <http://www.canada.ca/en/immigration-refugees-citizenship/services/immigrate-canada/inadmissibility.html>.

They will assess the visa requirements of your event.
